# **DERMARIN L**

Athlete's Foot and Ringworm Remedies

Tinea pedis and tinea are diseases caused by ringworm fungus growing in horny layer of skin surface. When ringworm fungus invade keratin in horny layer of skin surface, inflammation and severe itching occur in skin surface. DERMARIN L contains active ingredients that kill ringworm fungus, and relieve uncomfortable symptoms of tinea pedis. Once-daily application achieves therapeutic effect.

#### Indication

athlete's foot, jock itch, and ringworm

## Dosage and administration

Apply an appropriate dose onto the lesion once daily.

Comply with the prescribed dosage and administration instructions.

Clean the affected site and surrounding area before use.

Attention should be paid so that the medicine will not come into contact with eyes. In case the medicine comes into contact with eyes, immediately rinse them with water or lukewarm water, and immediately seek an ophthalmologist for medical treatment.

Use for children should be supervised by a parent.

The drug is for external use only.

In 100 g

Miconazole nitrate 1.0g

Crotamiton 10.0g

Lidocaine 2.0g

Dipotassium Glycyrrhizinate 0.5g

Carbamide 3.0g

## Excipients

Sorbitan stearate, Polysorbate 60, Self-emulsifying glyceryl stearate, Stearyl alcohol, Cetanol, Propylene glycol, Diisopropyl adipate, Methyl acrylate, 2-ethylhexyl acrylate copolymer, Polyoxyethylene nonylphenyl ether, Butylated hydroxytoluene, Sodium pyrosulfite, Edetate sodium, Dimethylpolysiloxane, Methylcellulose

#### **Precautions**

## When not to use the product

(If you do not follow these instructions, the current symptoms may worsen or adverse reactions are more likely to occur.)

• The medicine should not be used on the following parts:

Eyes and periorbital area, mucosa (for example, oral cavity, nasal cavity, vagina, etc.), scrotum, vulvar, etc. eczema

Lesions with severe moistening, erosion, fissures, and trauma.

#### Consultation

• The following persons should contact a physician, pharmacist, or registered salesperson for a consultation before use. Patients undergoing medical treatment from a physician

infants and small children

Patients who have experienced allergic symptoms associated with drugs, etc.

The lesion is on the face or an extensive area.

Patients with purulent hemorrhoidal lesions.

Those whose symptoms are not differentiated between "eczema" or "athlete's foot, jock itch, ringworm". (when symptoms such as itchiness/erosion are present on the scrotum, they are often attributed to other causes such as eczema.)

- If the following symptoms are observed after using this drug, these may be adverse reactions, so immediately discontinue the use, and show this document to your physician, pharmacist, or registered sales person for a consultation. Skin: rash/redness, swelling, itching, eruption, irritation, exfoliation, Hot sensation, soreserosion, Blisters, Dry/tight sensation, Burning sensation
- When symptoms do not improve even after using this medicine for 2 weeks, stop using this medicine and consult a physician, pharmacist or registered salesperson, being sure to take this instruction leaflet with you.

#### Precautions for storage and handling

Avoid direct sunlight, and store the product in a cool place with an air tight closure on.

Store the product beyond the reach of children.

Do not transfer the drug to other containers. (It may lead to misuse or quality deterioration.)

Do not use the product past the expiration date. Even within the expiration date, try to use it up as soon as possible once it is opened (to assure the quality).
