

IRIS CL- I NEO

Class 3 OTC drug
Ophthalmic Medicines

◆ IRIS CL- I NEO is a tear-substitute eye drop, and contains taurine. It can be used with contact lenses on. It does not contain any ingredient that is absorbed by, and accumulated in contact lenses, causing degeneration. That is why it can be safely used with soft, disposable, O2, and hard contact lenses on, and protects gently the eyes with contact lenses. It relieve dry eye (dry eye) It does not contain any preservative that could stimulate dried eyes and cause troubles. It contains compounds found in tear (sodium chloride, potassium chloride), as well as taurine. It moistens dried eyes, and provides nutrition, and gently relieves dry eyes and ocular fatigue when using a personal computer etc.

Indication

Eyestrain, prevention of dry-eyes, foreign-body feeling by contact lenses, blurred vision (eye mucus)

Dosage and administration

Instill 2 to 3 drops per dose 3 to 6 times daily.
Comply with the prescribed dosage and administration instructions.
When allowing children to use the medicine, a guardian must be present to watch and tell such them how to use it.
Do not touch the tip of the container with the eyelid or eyelash. Do not use the drug when the solution becomes turbid.
Use this only as an eye drop.
Do not forcibly tear it open. Be careful that the drug solution may be sprinkled if you open the drug forcibly.
This is a one-dose eye drop and does not contain any preservatives. Discard the remaining solution after use.

ingredient and amount

Taurine (Aminoethyl Sulfonic Acid) 1%
Sodium chloride 0.50%
Potassium chloride 0.10%

Excipients

Sodium bicarbonate, pH adjusting agent

- In case of the following, stop taking this medicine and consult a physician, pharmacist or registered salesperson, being sure to take this instruction leaflet with you.
When blurred vision does not improved.
When symptoms do not improve even after using the medicine for about 2 weeks

Precautions for storage and handling

Store this in a cool place, avoiding direct sunlight.
Store the product beyond the reach of children.
Do not transfer the drug to other containers. (It may lead to misuse or quality deterioration.)
Do not share the drug with other people.
Do not leave the drug under high temperatures, such as on a car dashboard. (It may result in the deformation of the container and the degradation of the drug solution.)
Note that the cap may come off if the drug is placed in the back pocket of pants.
Do not use the product past the expiration date. Even within the expiration date, try to use it up as soon as possible once it is opened (to assure the quality).
