<Eye Drops>

- Artificial tears with properties similar to those of natural tears, providing moisture to eyes with dryness issues associated with inability to produce sufficient tears.
- ◆ Contains constituent minerals (potassium chloride and sodium chloride) found in natural tears and ingredients that prevent tear evaporation and retain moisture in the eyes (hypromellose), protect the corneal surface that has been damaged by dryness (chondroitin sulfate sodium), which promote metabolism in the eyes (potassium L-aspartate and taurine) to improve eye dryness and fatigue.
- May be dispensed directly into the eye while wearing any type of contact lens (disposable, soft, O2, and hard) or without contact lenses.
- Packaged in single-use clean packs (individual packaging) to ensure freshness each time a vial is opened.
- ◆ A viscous eye drop that is easy to use and free of preservatives (benzalkonium chloride and parabens) and cooling agents (menthol).


Efficacy

Usage/Dosage

Apply to eyes 3 to 6 times daily, 2 to 3 drops each time.

[How to Use]



Note:

- (1) Strictly follow the prescribed usage and dosage.
- (2) If this medicine is being used by a child, ensure it is used under the guidance and supervision of a parent or guardian.
- (3) Do not let the tip of the container touch your eyelids or eyelashes. Do not use if the solution is cloudy.
- (4) Use only for application in the eyes.
- (5) Do not open by pulling forcefully. Avoid using excessive force when opening the vial. This may cause the solution to spatter.
- (6) IRIS CL-I PREMIUM MOISTURIZING CARE is a single-use ophthalmic solution and contains no preservatives. Discard any remaining solution after use.
