◆ TAISHO STOMACH MEDICINE K 〈TABLETS〉 is a gastrointestinal medicine that contains Shakuyakukanzoto extract powder and Anchusan. ■ Taisho gastrointestinal medicine K <tablets> that contains these 2 herbal medicines relieves gastrointestinal symptoms such as pain and heaviness in the stomach as well as gastritis.

Indication

Stomachache, heavy stomach feeling, gastritis, feeling of discomfort in the stomach, loss of appetite, belch, abdominal pain, heartburn, nausea, chlorhydria, feeling of abdominal distention

Dosage and administration

Take the following dose with cold or lukewarm water before a meal or between meals.

15 years or over: 4 tablets per dose, 3 times daily 5 to 14 years: 2 tablets per dose, 3 times daily

Under 5 years: Do not use

Comply with the prescribed dosage and administration instructions.

The use of the drug in children should be supervised by a parent.

Do not return the tablets touched by wet fingers into the jar. (It will cause discoloration and may deteriorate the quality.)

ingredient and amount

In 4 tablets

Anchusan 700mg (equivalent to 200mg of Cinnamon bark, 150mg of Corydalis tuber, 150mg of Oyster shell, 75mg of Fennel, 50mg of Amomum seed, 50mg of Glycyrrhiza, 25mg of Ryokyo)

Powdered Shakuyakukanzoto Extract 170mg (Peony root 340mg, Glycyrrhiza 340mg)

Excipients

Hydroxypropylcellulose, anhydrous silicic acid , Lactose , Magnesium stearate, hardened oil

Precautions relating to ingredient and amount

The drug contains herbal medicine as a raw ingredient. The color of the drug may differ slightly, but this will not affect the efficacy.

Pseudoaldosteronism, myopathy: In addition to listlessness, numbness, stretched feeling, and stiffness of hands and feet, feeling of weakness and muscular pain will appear and gradually progress

- When symptoms do not improve even after taking the preparation for about 1 month, stop taking the medicine and consult a physician (dentist), pharmacist or registered salesperson, being sure to take this instruction leaflet with you.
- If you take this medicine for a long time, consult a physician, pharmacist, or registered salesperson.
