Products for the oral
cavity and throat

- ◆ PABRON THROAT SPRAY 365 combines cetylpyridinium chloride hydrate, an antiseptic ingredient, and it is suitable for not only unpleasant symptoms caused by throat inflammation such as sore throat and swelling but also a little discomfort in the throat and a hoarse voice.
- ◆ The drug is directly delivered to the throat only by spraying 2 to 3 times, thereby exerting its effect. ◆ It has a lemon and mint flavor providing a fresh sensation after use. ◆ The Spray has a top cover so that it can be easily carried around.

Indication

hoarse voice due to throat inflammation, rough throat, throat discomfort, sore throat, and swollen throat.

Dosage and administration

Spray an appropriate dose on the mucous membrane of the throat a few times daily.

Comply with the prescribed dosage and administration instructions.

The use of the drug in children should be supervised by a parent.

Use the drug only for topical application. Do not take it orally.

If this drug is used as inhaling, the solution may enter the bronchi or lungs; therefore, direct the nozzle toward the affected area of the throat, and spray 2 to 3 times as lightly exhaling.

Attention should be paid so that the medicine will not come into contact with the eyes.

If the drug should get in the eye, immediately wash with cold or warm water, and immediately seek medical care from an ophthalmologist.

When using the drug for the first time, press a few times until the solution comes out, paying attention to your surroundings.

Do not push the edge of the nozzle with a needle, etc. It is very dangerous when it breaks.

ingredient and amount

In 100 mL

Cetylpyridinium chloride 0.3g

Excipients

Glycerin, D-Sorbitol, Propylene glycol, Anhydrous ethanol, Sodium citrate, l-Menthol, citric acid, flavor,,

Precautions

When not to use the product

(If you do not follow these instructions, the current symptoms may worsen or adverse reactions are more likely to occur.)

- Do not take this medicine for a long time

Consultation

The following persons should consult a physician, dentist or pharmacist before using the drug.

Patients undergoing medical treatment from a physician or dentist.

Persons who or whose family members have an allergic predisposition

Persons who have had an allergic symptom to drugs

Persons with the following symptoms:

Erosion inside the mouth.

In the following cases, immediately discontinue this drug, and consult a physician, dentist or pharmacist. Be sure to show this leaflet.

The following symptoms may occur after using the drug:

Skin

rash/redness

itching

Mouth:

Irritation

Gastrointestinal system

feeling of discomfort in the stomach

Nausea

If symptoms do not resolve after using the drug for 5 to 6 days

Precautions for storage and handling

Avoid direct sunlight, and store the product in a cool place with little humidity.

Do not leave the drug in places where temperatures may increase such as on a car.

Store the product beyond the reach of children.

Do not transfer the drug to other containers. (It may lead to misuse or quality deterioration)

Wipe around the nozzle with a piece of clean tissue paper after use before closing the cap.
Do not place the drug close to any source of flame.
Do not use the product past the expiration date.
Even before the expiration date, use up to within 6 months after it is opened (to assure quality).
