Comply with the prescribed dosage and administration instructions.

Use for children should be supervised by a parent.

The following serious symptoms may occur in rare cases. In such cases, immediately seek medical aid from a physician. Shock (anaphylaxis): Symptoms, such as itching of skin, urticaria, hoarseness, sneezing, itchy throat, breathing difficulties, palpitations, and clouding of consciousness may occur immediately after use.

Oculomucocutaneous syndrome (Stevens-Johnson syndrome), toxic epidermal necrolysis, acute generalised exanthematous pustulosis: Hyperthermia, ocular hyperaemia, eye discharge, lip erosion, pain throat, widespread skin rash/redness, small pimples (small pustules) on reddened skin, general malaise, anorexia, etc. may persist or suddenly worsen.

Precautions for storage and handling

Avoid direct sunlight, and store in a cool place with little humidity and temperature below 30℃.

Store the product beyond the reach of children.

Do not transfer the drug to other containers. (It may lead to misuse or quality deterioration.)

For storage, store in the outer box, place the tip downward, and stand them according to the instruction on the outer box. Do not take the product past the expiration date.

Even within the expiration date, use up as soon as possible once it is opened (to assure the quality).
