◆PRESER S suppository contains effective ingredients to treat hemorrhoids such as hydrocortisone acetate that inhibits inflammation. These ingredients relieve hemorrhoidal symptoms such as pain, bleeding, swelling, and itching.

Indication

To alleviate pain/bleeding/swelling/itching due to bleeding piles/blind piles

Dosage and administration

Insert the following dose into the anus.

15 years or over: 1 piece per dose, 1 to 3 times daily

Under 15 years: Do not take

Take a bath or wash the affected site with warm water before use. The effect is even better if the drug is used after defecation in the morning and before bed time in the evening.

Comply with the prescribed dosage and administration instructions.

If the drug is too soft, cool it for a while before use.

If the drug is too hard, leave the drug in room temperature for a while, and use it after it gets soft enough.

Use the drug only for the anus.

In 1 piece (1.65 g)

Hydrocortisone acetate 5mg

Lidocaine 60mg

I-Menthol 9mg

Allantoin 10mg

Tocopherol Acetate 50mg

Chlorhexidine Hydrochloride 5mg

Carboxyvinyl polymer, anhydrous silicic acid, Hard fat

Precautions

When not to use the product

(If you do not follow these instructions, the current symptoms may worsen or adverse reactions are more likely to occur.)

• This product should not be used in the following persons:

Persons who have had an allergic symptom to the drug or the drug ingredient, namely, chlorhexidine.

Patients with purulent hemorrhoidal lesions.

• Do not take this medicine for a long time

• The following persons should contact a physician, pharmacist, or registered salesperson for a consultation before use. Patients undergoing medical treatment from a physician

Pregnant women or women suspected of being pregnant.

Patients who have experienced allergic symptoms associated with drugs, etc.

If the following symptoms are observed after taking this drug, these may be adverse reactions, so immediately discontinue the use of this drug, and show this document to your physician, pharmacist, or registered salesperson for a consultation.

Precautions for storage and handling

Avoid direct sunlight, and store in a cool place with little humidity and temperature below 30°C.

Store the product beyond the reach of children.

For storage, store in the outer box, place the tip downward, and stand them according to the instruction on the outer box. Do not transfer the drug to other containers. (It may lead to misuse or quality deterioration)

Do not use the product past the expiration date.
