Indication

1) prevention and relief of dizziness, nausea, and headache associated with motion sickness

Dosage and administration

Take the following dose.

To prevent motion sickness, take 1 bottle per dose 30 minutes prior to boarding.

If you need to take an additional dose, then take 1 bottle per dose at an interval of at least 4 hours.

11 years or over: 1 bottle (20 mL) per dose, up to twice daily

Under 11 years: Do not take

Comply with the prescribed dosage and administration instructions.

The use of the drug in children (11 to 14 years) should be supervised by a parent.

In 1 bottle (20 mL)

Chlorpheniramine Maleate 2.6mg

Scopolamine Hydrobromide 0.16mg

D-Sorbitol ,Acesulfame K,Sucralose ,Sodium benzoate,citric acid,Sodium citrate,flavor

Precautions

When not to use the product

(If you do not follow these instructions, the current symptoms may worsen or adverse reactions/incidents are more likely to occur.)

This drug should not be taken together with the following drugs:

Other medicine for motion sickness, cold medicine, antipyretics/analgesics, sedatives, expectorant, indigestion and heartburn relief, internal medicine containing antihistamines, etc. (such as internal medicine for rhinitis and medicine for allergies)

• After taking this drug, do not drive a car or operate machinery (symptoms such as sleepiness, blurred vision and abnormal brightness may occur).
