

# VICKS Medicated DROPS SUGARLESS ACEROLA

Newly designated quasi-  
drugs

Products for the oral  
cavity and throat

## Indication

hoarse voice due to throat inflammation, rough throat, throat discomfort, sore throat, and swollen throat.  
Sterilization, disinfection, washing in the oral cavity and removal of mouth odor

## Dosage and administration

Put one each of the following amounts up to 2 pieces in your mouth, and do not chew but let it dissolve slowly.  
Adults (15 years or over) and children aged 5 years or over: 2 pieces per dose, 3 to 6 times daily  
Under 5 years: Do not use  
Use the drug at an interval of at least 2 hours.\* When using this drug, suck one piece each. Do not use 2 pieces at a time.

## [Precaution]

Comply with the prescribed dosage and administration instructions.  
When allowing children to use the medicine, a guardian must be present to watch and tell such them how to use it.  
Do not crunch or swallow the product.

## ingredient and amount

In 12 piece  
Cetylpyridinium chloride 6.0mg

## Excipients

Syrup reduction,D-Mannitol,New coccine,Silicone resin emulsion,Aspartame (L- phenylalanine compound),Citric acid,Vitamin C,l-Menthol,Talc,Flavoring,Eugenol

## Precautions

### Consultation

The drug easily gets moist; therefore, once you open the package, fold up the opening of the bag to store it.  
Do not use the product past the expiration date.
