# VICKS MEDICAL TROCHE

- ◆VICKS MEDICAL TROCHE is an antitussive and expectorant drug containing cetylpyridinium chloride hydrate, which is a disinfectant and antiseptic, dl-methylephedrine hydrochloride, which is an antitussive, and potassium guaiacolsulfonate, which promotes expectoration.
- ◆It is highly effective in soothing symptoms such as sore throat, throat irritation, and coughing due to throat inflammation.
- ◆ It is a green tea-flavored troche that is easy to take.

# Indication

Cough, cough with wheezing (wheezy, whistling), sputum, hoarse voice, sore throat, throat discomfort, throat pain, and throat swelling associated with throat inflammation

# **Dosage and administration**

Dissolve the following amount of troche in the mouth slowly without chewing, at intervals of at least two hours. 8 years or over: 1 tablet per dose, 6 times daily

Under 8 years: Do not use

#### Precaution

- Comply with the prescribed dosage and administration instructions.
- The use of the drug in children should be supervised by a parent.
- Do not crunch or swallow the product.
- How to take out the tablets

Press the convex part of the PTP sheet containing the tablet firmly with your fingertips, break the aluminum foil on the back side, and take out the tablets. (If the tablets are inadvertently taken together with the PTP sheet containing them, it will lead to unexpected accidents, such as the sharp edge sticking into the esophageal mucosa)

Cetylpyridinium chloride hydrate 1mg

dl-Methylephedrine Hydrochloride 6.25mg

Potassium Guaiacolsulfonate 22.5mg

Corn starch, anhydrous silicic acid, hydroxypropylcellulose, reduced maltose syrup, magnesium stearate, I-menthol, acesulfame K, sucralose, aspartame (L-phenylalanine compound), ferric oxide, brilliant blue, flavoring, vanillin, phenol
