Peony Root extract 30mg (equivalent to 120 mg of the crude drug)

Rehmannia Root Extract-A 150mg (equivalent to 300 mg of the crude drug)

Japanese Angelica Root Fluid Extract 0.05mL (equivalent to 50 mg of the crude drug)

Astragalus Root Fluid Extract 0.3mL (equivalent to300 mg of the crude drug)

Ginseng extractM 90mg (equivalent to 600 mg of the crude drug)

Muira Puama Extract-A 15mg (equivalent to 300 mg of the crude drug)

Agkistrodon Meat and Bones Tinctures 1.25mL (equivalent to 250 mg of the crude drug)
