Dosage and administration

Shake well before taking the drug.

Astragalus Root Fluid Extract 0.6mL (equivalent to 600 mg of the crude drug)
Polygonatum Rhizome Fluid Extract 0.6mL (equivalent to 600 mg of the crude drug)
Glycyrrhiza Extract 37.5mg (equivalent to 150 mg of the crude drug)
Jujube Viscous Extract 91mg (equivalent to 300 mg of the crude drug)
Japanese Angelica Root Fluid Extract 0.05mL (equivalent to 50 mg of the crude drug)
Bupleurum Root Fluid Extract 0.15mL (equivalent to 150 mg of the crude drug)
Ginger Tinctures 0.375mL (equivalent to 75 mg of the crude drug)
Epimedium Herb extract 100mg (equivalent to 1000 mg of the crude drug)
Agkistrodon Meat and Bones Tinctures 1.25mL (equivalent to 250 mg of the crude drug)
Taurine (Aminoethyl Sulfonic Acid) 500mg
Riboflavin sodium phosphate 5mg
Pyridoxine Hydrochloride (vitamin B6) 5mg
Anhydrous caffeine 50mg

Excipients

Sugar,D-Sorbitol ,Butyl parahydroxybenzoate,Sodium benzoate,Polyoxyethylene hydrogenated castor oil,Povidone ,citric acid,Sodium citrate,Caramel,flavor,alcohol (not more than 1.0mL)
