Rehmannia Root Extract-A 150mg (equivalent to 300 mg of the crude drug)

Japanese Angelica Root Fluid Extract S 0.05mL (equivalent to 50 mg of the crude drug)

Astragalus Root Fluid Extract A 0.3mL (equivalent to300 mg of the crude drug)

Ginseng extract-P 85.8mg (equivalent to 600 mg of the crude drug)

Muira Puama Extract-A 15mg (equivalent to 300 mg of the crude drug)

Polygonum tincture 0.76 mL (equivalent to polygonum root 250 mg)

Sugar, Sodium benzoate, Butyl parahydroxybenzoate, Polyoxyethylene hydrogenated castor oil, Povidone , citric acid, Sodium citrate, flavor, alcohol (not more than 1.38mL)
