Vitamin-containing health drugs

◆New ZENA F-III is a mini drink that contains a total of 15 herbal medicines (a total of 4950 mg of crude herbal medicine) that include horny goat weed, Cistanche herb, and tonic herbal medicine muirapuama which originated in Brazil, as well as taurine and vitamins. ☑
The product is very effective to supplement nutrition for those with persisting physical fatigue, who need to work harder even though being tired, or lose physical strength due to cold and other thermogenic degenerative diseases.

Indication

Nutritional supplements during physical fatigue, during and after illness (or when physical strength is impaired after illness), nutritional disorders, feverish wearing disease□
Loss of appetite
For nutritional supplementation during pregnancy/nursing
Nutrients/tonics
Weak constitution

Dosage and administration

Adults (15 years or over): Take 1 bottle (50 mL) per dose once daily.
Under 15 years: Do not take
Comply with the prescribed dosage and administration instructions.
The drug contains a herbal extract. Sedimentation may occur in rare cases. This does not affect drug efficacy.
Shake well before taking the drug.

Cnidium Monnieri Fruit extract 600mg (equivalent to 300 mg of the crude drug)
Eucommia Bark Extraction Liquid 0.3mL (equivalent to 300 mg of the crude drug)
Epimedium Herb extract 100mg (equivalent to 1000 mg of the crude drug)
Muirapuama Extract-A 15mg (equivalent to 300 mg of the crude drug)
Rehmannia Root Extract-A 100mg (equivalent to 200 mg of the crude drug)
Japanese Angelica Root Fluid Extract 0.2mL (equivalent to 200 mg of the crude drug)
Lycium Fruit Fluid Extract-A 0.2mL (equivalent to 200 mg of the crude drug)
Ginseng extractM 90mg (equivalent to 600 mg of the crude drug)
Astragalus Root Fluid Extract 0.3mL (equivalent to 300 mg of the crude drug)
Polygonatum Rhizome Fluid Extract 0.3mL (equivalent to 300 mg of the crude drug)
Schisandra Fruit Fluid Extract 0.15mL (equivalent to 150 mg of the crude drug)
Polygala Root Extract-A 15mg (equivalent to 150 mg of the crude drug)
Agkistrodon Meat and Bones Tinctures 1.75mL (equivalent to 350 mg of the crude drug)
Thiamine Nitrate 10mg
Riboflavin sodium phosphate 5mg
Pyridoxine Hydrochloride (vitamin B6) 5mg
Taurine (Aminoethyl Sulfonic Acid) 500mg
Anhydrous caffeine 50mg

Excipients

Sugar, Xylitol, Trehalose, Glycerol fatty acid ester, Polyoxyethylene hydrogenated castor oil, Glycerin, Povidone, Sodium benzoate, pH adjusting agent, Tricaprilin, flavor, alcohol (not more than 1.2mL)

No need to worry if you have yellow urine after taking the drug because it is caused by the vitamin B2 contained in the drug.
